**NOTIFICATION**

*Dated Dispur the 27<sup>th</sup> December, 2016.*

**No.FT.142/2015/28:** In exercise of the powers conferred by sub-section (2) of section 6 of the Assam Entry Tax Act, 2008 (Assam Act, XII of 2008) the Governor of Assam having considered it necessary in the public interest so to do, hereby exempts the organization of the State Government shown in column (1) of the Table below from the liability to pay entry tax in respect of import of the following items for exclusive use under the Universal Immunization Programme of the Government of India subject to the restrictions and conditions specified in column (4) of the said table:-

Director of Health Service (FW), Assam, Hengrabari, Guwahati-3	Vaccines of all kind	21.67 Lac	1. That the goods imported are exclusive property of the organization as specified in column (1). 2. That the organization is permitted to import quantity specified in column (3) of goods specified in column (2). 3. That the Organization shall obtain Road Permits (Form-62) for import of goods specified in column-2 and submit utilization of such Road Permits within one month from the date of the receipt of the goods or at the time of application for issuance of fresh Road Permit, whichever is earlier. 4. That the goods are supplied free of cost by Government of India through its Government Medical Store Depot (GMSD) or approved vendors. 5. That the goods, so imported on the strength of this notification, are exclusively used for the immunization programme. 6. That the exemption shall be valid upto 31.03.2017.


