No.FTX.47/2013/Pt/104 : In exercise of the powers conferred by sub-section (4) of section 3 of the Assam Entry Tax Act, 2008 (Assam Act No. XII of 2008), the Governor of Assam, having considered it necessary in the public interest so to do, is pleased to vary the rate of tax of the specified goods in serial numbers 2, 3, 4, 5, 6(i), 7, 31, 35, 55 (d), (g) & (i), 64 and 65 in the Schedule to the said Act, namely:-
