# GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR FINANCE (ESTABLISHMENT-B) DEPARTMENT

#### **NOTIFICATION**

The 23rd August, 2016

No.FEB.45/2009/165.- In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Assam is hereby pleased to make the following rules further to amend the Assam Local Fund Audit Service Rules, 1997, hereinafter referred to as the principal Rules, namely:-

## Short title and commencement.

- 1. (1) These rules may be called the Assam Local Fund Audit Service (Amendment) Rules, 2016.
  - (2) They shall come into force on the date of their publication in the Official Gazette.

## Amendment of Rule 2.

- 2. In the principal Rules, in rule 2, for the existing clause (a), the following shall be inserted, namely:-
  - "(a) "Appointing Authority" means,-
    - (i) the Governor of Assam in respect of the posts of Joint Director of Audit (Local Fund), Deputy Director of Audit (Local Fund), Assistant Director of Audit (Local Fund) and Audit Officers; and
    - (ii) the Director of Audit (Local Fund) in respect of the posts of Assistant Audit Officer."

## Amendment of Rule 3.

- **3.** (1) In the principal Rules, in rule 3, for the existing sub-rule (1), the following shall be substituted, namely:-
  - "(1) The service shall consist of the following cadres:-
    - (a) Joint Director of Audit (Local Fund),
    - (b) Deputy Director of Audit (Local Fund),
    - (c) Assistant Director of Audit (Local Fund),
    - (d) Audit Officer,
    - (e) Assistant Audit Officer."
  - (2) In the principal Rules, in rule 3, in sub-rule (2), for the existing clause (a) and (b), the following shall be substituted, namely:-
  - "(a) The members of the service in the cadre of Joint Director of Audit (Local Fund) and Deputy Director of Audit (Local Fund) shall belong to Group A,Grade-I Government Service and the Assistant Director of Audit (Local Fund) shall belong to Group A, Grade-II Government service, Audit Officer shall belong to Group-B Government Service.

(b) The members of the service in the cadre of Assistant Audit Officer shall belong to Group-C Government service."

### Substitution of Rule 13.

4.

- In the principal Rules, for the existing rule 13, the following shall be substituted, namely:-
- "(1) "Joint Director of Audit (Local Fund),-
- (a) Vacancy in the cadre of Joint Director of Audit shall be filled up by promotion from the cadre of Deputy Director of Audit(Local Fund) on the basis of merit with due regard to seniority by the Appointing Authority subject to the following conditions, namely,-
  - (i) he has rendered service as Deputy Director for a minimum period of 2 years on the first January of the year of promotion; and
  - (ii) he has successfully undergone training and passed departmental examination, if any, as may be prescribed for the purpose;
  - (iii) he will be responsible for inspection, evaluation and monitoring of the audit function of the Directorate.
- (2) Deputy Director of Audit (Local Fund),-
- (a) The vacancies in the cadre of Deputy Director of Audit (Local Fund) shall be filled up by promotion from the cadre of Assistant Director of Audit (Local Fund) on the basis of merit, with due regard to the seniority by the Appointing Authority subject to the following conditions, namely,-
  - (i) he has rendered service as Assistant Director for a minimum period of 3 years on the first January of the year of promotion; and
  - (ii) he has successfully undergone training and passed departmental examination, if any, as may be prescribed for the purpose.
- (3) Assistant Director of Audit (Local Fund),-
- (a) All vacancies in the cadre of Assistant Director of Audit (Local Fund) shall be filled up by promotion from the cadre of Audit Officer on the basis of merit with due regard to seniority by the Appointing Authority subject to the following conditions, namely,-
  - (i) he has rendered service as Audit Officer for a minimum period of 5 years on the first January of the year of promotion;
     and
  - (ii) he has successfully undergone training and passed departmental examination, if any, as may be prescribed for the purpose."

## Amendment of Rule 14.

5.

In the principal Rules, for the existing rule 14, the following shall be substituted, namely:-

"14 Selection Board – The Board shall consist of the following members for considering promotion to the post of Joint Director of Audit (Local Fund), Deputy Director of Audit (Local Fund) and Assistant Director of Audit (Local Fund)"-

(I) Commissioner and Secretary/or in his absence Secretary to the Government of Assam, Finance Department or his nominee not below the rank of Secretary

(ii) Director of Audit (Local Fund)

..... Member

(iii) Secretary to the Govt. of Assam, Personnel Department or his nominee ..... Member

(iv) Deputy Secretary to the, Govt. of Assam Finance Department ..... Member Secretary".
