The Government of India seeks to promote digital payment methods to encourage consumers and merchants to increasingly shift to these payment modes. The present two schemes, namely Lucky Grahak Yojana for Consumers and Digi-Dhan Vyapar Yojana for Merchants, seek to nudge people towards significantly higher usage of digital transactions through the offer of incentives.

Awards will be given out on a daily and weekly basis under the Lucky Grahak Yojana and weekly basis under the Digi-Dhan Vyapar Yojana. Detailed guidelines will be made available on the NITI Aayog website. The scheme will be implemented by National Payments Corporation of India (NPCI).

Only those transactions that take place through RuPay Cards, USSD, UPI and AEPS are eligible for this scheme. The draws for these events will be taken out in 100 different cities around the country, in a ceremony accompanied by a digital payments adoption fair called DigiDhan Mela. This event should be used to as a platform to promote digital payments.

This document is aimed to provide guidance to the State organising committee/ District Collector for the organization of the event in their cities.

<u>Detes of Scheme:</u> The scheme will become operational with the first draw on 25th December, 2016 (coinciding with Christmas) leading up to 14th April 2017 (coinciding with Babasaheb Ambedkar Jayanti) with a Mega Draw.

Details of Events: The event in each city will have three components:

- a. One hour inauguration function: At a one hour event, the draw of the day will be carried out, in the presence of a dignitary and a national-level celebrity, preferably belonging to the state (sportsperson, film personalities, etc). A broad agenda of the function is detailed in next section 3a.
- b. <u>Day Long DigiDhan Mela:</u> To encourage adoption of digital payments by local residents, this event will have a daylongDigiDhanMela where local residents can interact with banks and other stakeholders, get apps downloaded and learn how to do digital transactions.

c. Lead up contests: Contests to encourage local community participation in the initiative leading up to the day of draws. Certificates will be given out during the one hour award ceremony for (i) best slogan (ii) best jingle (iii) best poster on digital payments in local language. States may further consider giving awards/ cash prizes to winners, as deemed fit. States may like to organise their own creative contests through local sponsorships. This will be coordinated by Shri Gaurav Dwivedi, CEO, MyGov.in(Contact Details: Tel. No. 011-24364706, E-mail: ceo@mygov.in)

Organizing Committees of Local Events: The event will be organized by the District Collector, and coordinated by Secretary, IT of the State as the Nodal Officer, under the supervision of Chief Secretary of respective states. Advisor, NtTl Aayog of the relevant state will provide all help and assistance. The committee will comprise the following functionaries. The indicative responsibilities are listed out in the table below. However, the local state administration will have the requisite flexibility to invite the cooperation of any agency they deem suitableto make the event successful.
