Sir,

This has reference to the above and the training program organized from 3rd March to 6th March, 2017 in this regard. It is noted that officers under few HoDs have not attended the training.

It is reiterated that, the Budget should compulsorily be distributed to the DDOs, for the DDO to incur any expenditure against the respective Head of Account. To facilitate the smooth implementation of the new process, it is also mandatory for all DDOs to be verified by the respective Administrative Department / HoD. As the Distribution of Budget facility will be enabled tentatively by 15th March, 2017, it is required that all DDOs are verified and their complete information updated on the Finance Department Portal (finassam.in) before 15th March, 2017.

It may be noted that for those <u>DDOs</u> whose <u>details</u> are not <u>verified</u> and updated on the Finance Portal, the respective Departments / HoDs <u>will not be able to distribute the budget</u> and consequently the <u>DDO</u> will not be able to submit bills at the <u>Treasury</u> for any expenditure.

For the benefit of those who did not attend the original programme, one more training program is scheduled on 14th March, 2017 at the Training Hall (1st Floor, 'F' Block), Finance Department. You are once again kindly requested to nominate the concerned officers for the training as per the attached schedule.
