



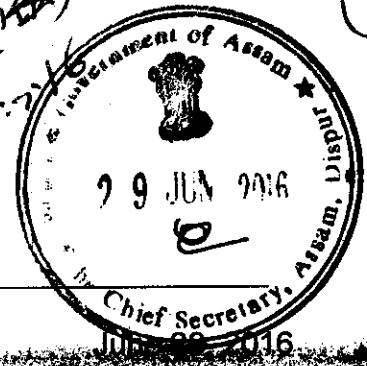

Govt. of Assam, vide its Memo. No.FIF.41/2006/938 dated September 5, 2014 to the District Commissioners / Superintendent of Police that the Assam Protection of Interest of Depositors (in Financial Establishment) (Amendment) Act 2013 is applicable only to

registered with RBI as non-deposit taking NBFCs or to Micro Finance Companies licenced under Section 25 of the Companies Act, 1956, which are not authorized to accept deposit from public.
