Annexure 1: Scope of the "Public Procurement Act"

Scope: The scope of the "Public Procurement Act" should cover:

- the objectives and principles of public procurement to serve as an effective guide for procurement decisions to be taken by different Departments, while allowing adequate flexibility to them to cater to their specific needs.
- Provide an enabling envelope of procedures of procurement, and methods of procurement and their conditions of use in order to ensure that the procuring authorities remain within such an envelope while detailing procedures and methods of procurement.
- Applicability and exclusions under certain defined circumstances to various entities (Government
 departments, public sector enterprises, urban local bodies, statutory bodies and autonomous bodies)
 and also to various categories of procurement (security, emergencies, and smaller procurements
 below prescribed thresholds etc).
- Effective grievance redressal system to address unlawful actions prior to signing of the procurement contract and to a limited extent after signing of contract. The grievance system should have safeguards to prevent procurement turning into a playground of lawyers and malicious petitioners.
- The Act should provide for envelops within which following must be ensured:
 - ✓ transparency in need assessment, description and specification of requirements
 - ✓ adequate competition in public procurement by broad-basing the bidders;
 - ✓ adequate and effective publicity; disclosures and public opening of bids;
 - ✓ promotion of e-procurement;
 - ✓ criteria for determining the qualification / eligibility of bidders;
 - ✓ the evaluation of bids;
 - ✓ restricting cartelisation and anti-competitive behaviour;
- The Act should provide for setting up of avenues to ensure that the penal provisions of Act are enforced expeditiously for
 - ✓ violation of the Act by the procurement authority/ staff;
 - bidders' acts such as misrepresentation of facts with a view to obtaining award of contract or receiving undue benefit from the government, lodging of false claims;
 - ✓ Undue interference in the bidding process, securing undue gains, wasting a bid process, noncompliance with the directions of the Tribunal etc.
- The Act should provide only a minimal judicial review of administrative function of procurement without encumbering legal system with the details of procurement decisions.

Annexure II

TERMS OF REFERENCE FOR TASK FORCE TO DRAFT PROCUREMENT POLICY, LAW AND RULES FOR GOVT. OF ASSAM

Background: The Government of Assam (GoA) has been engaged for quite some time, in Public Finance Management (PFM) reforms with the objective to stabilize and consolidate state finances and thereby to enhance growth and reduce poverty, and to improve fiscal governance through legal, regulatory, and institutional reforms. GoAalso recognizes the need for Procurement Reforms, to both strengthen the legal framework and capacity in procurement in order to meet its ambitious public investment plans.

Accordingly GoA intends to develop & adopt a Public Procurement Policy¹ and Public Procurement Act, supported by appropriate and comprehensive procurement rules and bidding documents and has constituted a Task Force for the same. Enactment of Public Procurement Act and adoption of aPublic Procurement Policy Statementwouldjointly serve as a starting point and sound foundation as well as an overarching reference point for furtherenvisaged comprehensive Public Procurement reforms e.g. establishment of a nodal Public Procurement Policy & Technical Unit within the Department of Finance; development of Procurement Rules, Manuals and Standard Bidding Documents; building up of Professional and Institutional Capacity in Public Procurement and gradual scale up of a complete e-Procurement system from the current e-tendering system.

Need for the Public Procurement Act: currently procurement in Assam is governed by the Financial Rules, which have not evolved over time to cater to new models and approaches to procurement. Assam Institute of Management (AIM) which has been carrying out the function of procurement observatory over the last 2 years and has engaged with 8 large departments in Assam, has developed a draft procurement policy based on its experience and review of procurement law of the States of Rajasthan, Karnataka and Tamil Nadu.

Terms of reference for the Task Force: The task force constituted by GoA, Finance Dept will (i) frame a draft "Public Procurement Actof Assam" and "Public Procurement Policy Statement of the Government of Assam" and recommend the same to for adoption by the Govt and (ii) frame draft procurement rules and procedures of Assam, in conformity with the draft law. The task force shall:

- Carry out in-depth research and study of UNCITRAL's Model Public Procurement Law and its Guidelines for implementation
- Carry out in-depth research and study of Public Procurement Policy Framework of those States/
 Countries who have explicitly adopted Public Procurement Law and/ or Public Procurement Policy
 Statement and their relevance in context of Assam. Specific reference may be made to the

¹The "Public Procurement Policy Statement" is an overarching reference point for all policies in Public Procurement. It outlines the vision of the Government as to the direction in which the Government intends to move in medium and long term with regard to Public Procurement. The "Statement" also highlights the obligations and code of integrity expected by the Government from its own officers and also from vendors. United Nations Commission for International Trade Law (UNCITRAL) in its work on Model Public Procurement Law and Guidelines for implementation of the Model law has recommended adoption of Public Procurement Policy Statement. In India also it was advocated by the Committee on Public Procurement (Dhall Committee) in its report.

Rajasthan, which was the latest state to enact a procurement Act and the draft Public Procurement Bill of Govt. of India.

- Review the procurement rules in Govt of Assam with by benchmarking the same with rules developed by other states.
- Hold consultations with identified Stakeholders for understanding the ground position and seeking suggestions.
- Preparation of a Draft Public Procurement Act (see annex 1 for board scope of PPA) and Draft
 Public Procurement Policy Statement and circulating it to identified Stakeholders, including Dept of
 Law regarding the Public Procurement Act.
- Holding a joint consultative meeting with identified stakeholders for advocacy and feedback about the Drafts.
- Submit final (i) Public Procurement Bill and Public Procurement Policy Statement incorporating
 final remarks of GoA and (ii) submit draft procurement rules to GoA.

Length and Time Frame: the task force is expected to submit its final report to the GoA by Nov 30 2016.
