NOTIFICATION

No. FEB. 122/2015/28: In relaxation of Finance Department's earlier Office Memorandum issued vide No.FSI.5/2005/Vol-VI/76 dtd 30th March,2012 and FSI.5/2005/Vol-VI/99 Dtd 7th July,2015 and in order to streamline the process of instruction of Finance Department to the treasuries for releasing the first salary and in order to ensure timely release of salaries to the newly joined employees, the matter has been further reviewed and the Governor of Assam is pleased to notify as follows:

- (a) All Grade –I & Grade-II posts against which pay slips are issued by the Accountant General, Assam, drawal of first salary from the Treasury is hereby permitted based on the pay-slip issued by the Accountant General, Assam. It is further clarified that these cases shall not be sent to Finance (SIU) Department for issuing instruction to the Treasuries for releasing the first salary and no such separate permission from the Finance (SIU) Department is required.
- (b) Henceforth, permission of Finance (SIU) Department shall be mandatory only for Grade III & Grade IV category of posts. It may be mentioned that for these posts, Accountant General, Assam does not issue pay slips and the permission from Finance (SIU) Department will act as such pay-slip. Further, if any employee of Grade-III or Grade-IV joins a new place on transfer which requires drawal of salary from a new Treasury, a fresh permission from Finance (SIU) Department will be required. If transfer of an employee takes place within the same treasury, no fresh permission from Finance (SIU) Department is required in such case. It may be mentioned here that these posts are normally not transferrable though.

This will come into force from the date of issue of this O.M and Finance (SIU) Department may return all the cases falling under category (a) above under its examination to the line departments immediately.

This notification comes into force with immediate effect.
