ORDERS BY THE GOVERNOR

FEB. 744870/ 11 :Whereas, Shri Utpal Kumar Misra, AFS, Director (Finance), Health and Family Welfare Department and the then Joint Director of Pension was appointed by the Director Pension Assam, as Inquiry Officer, to enquire the case of Departmental proceedings against Smti Mamta Begum, Jr. Asstt (U/S), Direction of Pension, Assam vide order dated DP-288/2027/146 dated 27.08.2025; and

Whereas, Shri Utpal Kumar Misra, AFS on 14.10.2025 after a lapse of 48 days declined to take responsibility of the Enquiry Officer due to his promotion to post of Director (Finance), Health and Family Welfare Department; and

Whereas, Shri Utpal Kumar Misra, AFS, while he was serving as Joint Director of Pension did not take any step to conduct the Departmental proceeding entrusted to him vide order referred to above, and

Whereas, Shri Utpal Kumar Misra, AFS has failed the government by not carrying out his assigned duty to conduct the Departmental proceeding and failed to display of devotion to duty which amounts to violation of the Assam Civil Services (Conduct) Rules, 1965; and

Therefore, the Governor of Assam is satisfied that it is necessary to place Shri Utpal Kumar Misra, AFS, Director (Finance), Health and Family Welfare Department under suspension from service with immediate effect in the interest of public service;

Now, therefore, pending drawal of Departmental Proceeding, Shri Utpal Kumar Misra, AFS is placed under suspension from service under Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.

During the period of suspension, the headquarters of the said Shri Utpal Kumar Misra, AFS will be the same as his last substantive place of posting, subject to review if deemed necessary.

Shri Utpal Kumar Misra, AFS, Director (Finance), Health and Family Welfare Department is allowed to draw subsistence allowance as admissible under Rule FR 53 (1) (ii) (a) of the FRs and SRs, subject to production of non-employment certificate to the Deputy Secretary, General Administration (Secretariat Accounts) Department under sub-rule (2) of FR 53.
