FEB. 744863/ 11: Whereas, Shri Nikunjalal Das, AFS , Senior Financial Adviser , Industries, Commerce & Public Enterprises Department also allowed to hold the additional charge of Joint Director of Pension was appointed by the Director Pension Assam , as Inquiry Officer , to enquire the case of Departmental proceedings against Smti Mamtaz Begum, Jr. Asstt (U/S), Direction of Pension, Assam vide order dated DP-288/2027/147 dated 15.10.2025; and

Whereas, Shri Nikunjalal Das, AFS on 16.10.2025 requested the Director of Pension to withdraw his name as the Inquiry Officer as he is overburdened with the financial affairs of more than five departments, in addition to discharging his duties as Jt. Director of the Directorate; and

Whereas, Shri Nikunjalal Das, AFS has failed the government by not carrying out his assigned duty to conduct the Departmental proceeding and failed to display of devotion to duty which amounts to violation of the Assam Civil Services (Conduct) Rules, 1965 ;and

Therefore, the Governor of Assam is satisfied that it is necessary to place Shri Nikunjalal Das, AFS, Joint Director of Pension , under suspension from service with immediate effect in the interest of public service;

Now, therefore, pending drawal of Departmental Proceeding, Shri Nikunjalal Das, AFS is placed under suspension from service under Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.

During the period of suspension, the headquarters of the said Shri Nikunjalal Das, AFS will be the same as his last substantive place of posting, subject to review if deemed necessary.

Shri Nikunjalal Das, AFS , Senior Financial Adviser , Industries, Commerce & Public Enterprises Department is allowed to draw subsistence allowance as admissible under Rule FR 53 (1) (ii) (a) of the FRs and SRs, subject to production of non-employment certificate to Deputy Secretary, General Administration (Secretariat Account) Department under sub-rule (2) of FR 53.
