ORDERS BY THE GOVERNOR

FEB.744814/ 11: Whereas, Shri Jitul Borah, AFS , Senior Financial Adviser , Welfare of Minorities & Development was also allowed to hold the additional charge of Joint Director of Pension . He was appointed by the Director of Pension Assam , as Inquiry Officer, to enquire the case of Departmental Proceeding against Smti Mamtaz Begum, Jr. Asstt (U/S), Direction of Pension, Assam vide order dated DP-288/2027/149 dated 17.10.2025; and

Whereas, Shri Jitul Borah, AFS after a lapse of 26 days on 12.11.2025 requested the Director of Pension to withdraw his name as the Inquiry Officer on the plea that he could spare very little time in the Directorate as he has been holding many charges along with the additional charge as Jt. Director of Pension; and

Whereas, Shri Jitul Borah, AFS ,holding additional charge of the Joint Director Pension did not take any steps in respect of the Departmental Proceeding entrusted to him, and

Whereas, he has failed the government by not carrying out his assigned duty to conduct the Departmental proceeding and failed to display of devotion to duty which amounts to violation of the Assam Civil Services (Conduct) Rules, 1965 ;and

Therefore, the Governor of Assam is satisfied that it is necessary to place Shri Jitul Borah, AFS, Joint Director of Pension , under suspension from service with immediate effect in the interest of public service;

Now, therefore, pending drawal of Departmental Proceeding, Shri Jitul Borah, AFS is placed under suspension from service under Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.

During the period of suspension, the headquarters of the said Shri Jitul Borah, AFS will be the same as his last substantive place of posting, subject to review if deemed necessary.

Shri Jitul Borah, AFS , Senior Financial Adviser , Welfare of Minorities & Development is allowed to draw subsistence allowance as admissible under Rule FR 53 (1) (ii) (a) of the FRs and SRs, subject to production of

non-employment certificate to the Deputy Secretary, General Administration (Secretariat Accounts) Department under sub-rule (2) of FR 53.
