OFFICE MEMORANDUM

Sub. Filling up of sanctioned vacant Gr-III and Gr-IV posts in Sixth Scheduled areas in modification to OM No. FSI 5/2005/Vol-VI/76 dtd, 30/03/12

Government vide OM No. FSI.5/2005/Vol-VI/76 dated 30-03-2012 had relaxed the provisions contained in the Govt OM No. BW.21/99/98 dated 04-07-2005 with regard to filling up of duly retained essential vacant posts of different categories, by entrusting the responsibility of issuing prior approvals for filling up of required numbers of Grade I, II and III existing vacant posts, excluding the posts of teachers of Elementary Schools, Driver and Gr-IV to the concerned Heads of Administrative Departments i.e. to the Senior most Secretary of the Department on the condition that the Senior most Secretary of the concerned Heads of Administrative Departments shall issue prior approvals for filling up duly created and retained vacant sanctioned posts for a financial year in consolidated orders under his/her signature clearly indicating the original creation no. and last retention no. of the posts with intimation to the Finance (SIU) Department after due examination/diligence.

This was further to the conditions that only existing sanctioned vacant Grade I, II and III posts that are essential for public purposes shall be so approved for filling up and such posts shall be filled up strictly in compliance with the provisions of AFRBM Act, 2005, Reservation Act, other relevant Acts and Rules, Rulings of Hon'ble Supreme Court as well as Orders of the Hon'ble High Court in WP(C) No-6222/2003 and other relevant rulings/orders thereof and strictly in accordance with valid Service Rules, due procedure established by law etc and after issuing advertisement in newspapers as laid down.

The Government after careful consideration with the approval of Cabinet has decided to delegate the power of the filling up of Gr-III and Gr-IV District cadre posts in respect of the transferred departments of the Sixth Scheduled areas of Karbi Anglong Autonomous District Council (KAAC), North Cachar Hills Autonomous Council (NCHAC) and the Bodoland Territorial Council (BTC) to the respective authority of the Council and is pleased to revise the existing OM No FSI 5/2005/Vol-VI/76 dtd, 30/03/12 for filling up of Gr-III and Gr-IV District cadre posts in the Sixth Scheduled Areas in the following manner.

1. The Principal Secretary of the respective Autonomous District Council shall issue prior approvals for filling up of duly created and retained vacant sanctioned Grade-III and Gr-IV District cadre posts in respect of transferred departments of Sixth Schedule Areas (except all posts of teachers of Elementary Schools and Driver) instead of obtaining prior approval from concerned Administrative Departments as required as per Paragraph 4 of the OM dtd , 30-03-2012.
2. For creation of new posts or up-gradation of existing posts, all authorities including other Administrative Departments will continue to move Finance Department as per existing procedure.
3. Sweeping and cleaning services are to be outsourced and posts of sweepers shall not be filled up in any Department including the authorities in Councils on any ground, including compassionate ground, except in Govt. Hospitals.

The other procedures to be followed by the concerned Council Authorities shall continue to remain operational as per the existing OM No. FSI 5/2005/Vol-VI/76 dtd , 30-03-2012.
