

**18 Key Initiatives** 

#### SVAYEM (Swami Vivekananda Assam Youth Empowerment) Yojana

- Under this programme, one lakh youth will be provided suitable credit support for taking up income generating enterprises. The loan amount will be up to Rs. 1 Lakh for the new business and up to Rs. 2 Lakh for the existing entrepreneurs.
- State Government will provide 20% subsidy and will also set up 'Risk Fund' with select banks so that the banks will be encouraged to advance loans without much hesitation of recovery issues.
- Detailed Guidelines of SVAYEM Yojana will be issued soon. For this purposes, Rs.200.00 crore towards 20% subsidy and Rs.100.00 crore for risk fund have been set apart.

#### Kanaklata Mahila Sabalikaran Yojana (KAMS)

- The Government of Assam proposes to promote 1 lakh women self-help groups. Each SHG will be extended a financial support upto Rs.5.00 lakh as loan including capital subsidy over a period of time. An initial grant of Rs.25,000/- will be provided to each group in the current financial year and then subsequent support will depend on fulfilling a set of criteria.
- This programme will help more than 10 lakh women in the State directly and accordingly Rs.250.00 crore has been allotted in the current financial year for this.
- Further, the Government will exempt the women SHCs from stamp duty for documentation related to Bank loan upto Rs.2.5 lakh in the financial year 2017-18.

#### Gene Bank for Indigenous Fish (GBIF)

- For the conservation of the 82 endangered indigenous fish population of Assam like Puthi, Dorikona, Baralia, Khalihana,
  Chelakani, Bata, Aleng etc, a program for the conservation of the germplasm, propagation and restoration has been planned
- H With the aim of conserving the Fish Biodiversity a scientific directory of indigenous fish species along with a data base of genebank of entire Assam is being planned.
- It is proposed to initiate a Scientific Conservation Programme for Indigenous Fish (SCoPIF) by involving the Fishery College of Assam & the Fisheries Department, covering both experimental and natural habitat at an estimated cost of 9.36 crore.
- **For this purpose, Rs. 2.00 crore has been allocated in the Current Budget to kick start the project.**

#### Reforms In Mid-Day Meal: Bi-Weekly Eggs & Cooking Gas

- The Government of Assam has decided to provide eggs to all 42.61 lakh children in the Lower Primary and Upper Primary schools twice a week as part of the Mid Day Meal programme at a cost of about Rs 130 crore per year.
- Further, the Government intends to provide cooking gas connection to every Government school providing Mid Day Meal. This will not just help our children get faster and hotter meals but also reduce the environmental impact.
- Moreover, to ensure the timely availability of funds for the various expenditures involved like purchase of raw materials, remuneration of cooks, other incidental expenses etc. the Government of Assam proposes to introduce a system something akin to Green Channel wherein the required amount is released by the State Government in a timely manner without waiting for releases from Government of India.

#### **Price Stabilisation Fund**

Government of Assam plans to set up a Rs. 150 Crore "Price Stabilization Fund" to be at the disposal of the Food & Civil Supplies department for them to step in and correct any market failures which lead to rapid increase in the prices of essential commodities.

#### **Financial Incentives For Ujwala**

In order to incentivize the adoption of LPG connections by BPL families, the Government of Assam plans to provide financial assistance of Rs 1000/- per family in addition to the incentives provided by Government of India through it Ujwala scheme which aims to provide free LPG connections to BPL families. This will fasten the adoption of LPG connections and transform the kitchens of Rural Assam in a rapid manner. For this purpose, Rs. 5 crore has been allocated in this Budget.

# Tejasvi Navadhitamastu Edu-Infra Funds (TNEIF): Development of Professional Colleges and Universities

The Government of Assam proposes to allocate special grants of Rs. 667 crore in the name of Tejasvi Navadhitamastu Funds for infrastructure development of Professional Colleges and Universities to be spent over a period of three to four years as detailed here:

Further, the Government of Assam will start 8 women colleges in Minority dominated areas, three Government Degree Colleges, three Polytechnics, 20 B.Ed Colleges (one each in Karbi-Anglong, Dima Hasao and B.T.A.D areas), 33 Skill Development centers, one Dairy Science College at Sorbhog, one Agro Forestry and Biodiversity College at Kukilabari, a new University of Veterinary and Life Science by carving from Assam Agriculture university, a new Cultural University in Majuli and three Universities at Hojai, North Lakhimpur and Barpeta District.

#### City Infra Development Fund (CIDF)

- The Government of Assam is launching the 'City Infra Development Fund (CIDF)' worth Rs.1200 crores to be spent on big public infrastructure projects, in the 6 large cities of the State with more than one lakh population: Silchar, Tinsukia, Jorhat, Dibrugarh, Nagaon and Tezpur.
- In this budget, Rs 120 crore has been allocated for this purpose. This amount is planned to be spent on the development of projects like river-front, Public Parks, Landmark Roads, Marriage halls, District Libraries, District Stadiums etc. For instance, in Dibrugarh, Riverfront development will be one of the big priorities.

#### CMSGUY - Entry Point Activities

- Rs. 500 crore has already transferred to the Mega Mission Society and Rs. 1000 crore more has also been provided in the Supplementary Demand of 2016-17. Other Missions under the Mega Mission are being registered.
- Further, the Governing Council of the Mega Mission Society under the Chairmanship of our Hon'ble Chief Minister has recently decided to implement three important entry-point activities. These include:
  - 1. Supply of new tractors for farm mechanization
  - 2. Football field development in convergence with MGNREGA
  - 3. Establishment of Knowledge Centres.

#### **Mission Muga**

- In Assam, strength of silk industry lies in 16.43 lakh weavers and 2.75 lakhs rearers and we all know 99% weavers are women. To increase the production of Muga silk by 10 times by the year 2026 and for Assam to emerge as a leader in the world market, an ambitious Mission Muga is being announced in this budget.
- Such a programme requires a comprehensive and integrated mission mode project to cover whole range of activities from growing a large scale host plantation of Muga, Saulu, Dighlati, involving the Muga rearers, weavers and upto marketing through modern outlets and on e-marketing over internet to reach the customers globally.
- We have a registered society in the Handloom Textiles & Sericulture Department namely Assam Silk Outreach Mission Society which will be responsible for taking up such this project to achieve the target of producing one million kg Muga by 2026.
- Further, the Government proposes to develop nurseries & host plantations in 500 hectares in Government lands, 2000 hectares in degraded forest area & 8000 hectares in private individuals' lands during 2017-18.
- **For this purpose, Rs.100.00 crore has been allocated in this budget.**

#### Zero Interest On Crop Loans

- To encourage the uptake of credit by our farmers, Government of Assam proposes to introduce "Zero Interest Crop Loans" by giving 100% interest subventions on agricultural loans taken by farmers of Assam.
- Perhaps Assam is the first state in the country to take such a transformative intervention to drive agricultural loans which will encourage the farmers to avail loans for agricultural purposes and help the rural economy. For this purpose, Rs. 25 Crores have been allocated in the budget 2017-18.

#### Financial Incentives For Farmers Using Kisan Credit Cards (KCC)

- To re-activate the over 8 Lakh inactive KCC's, the Government of Assam proposes to introduce a one-time cash incentive of Rs. 3000 per inactive KCC holding farmer if he renews the Card.
- x A detailed guideline will be issued for this purpose and an amount of Rs. 65 Crores has been allocated in this budget.

#### Conversion Of 1000 Timber Bridges Into RCC Bridges And Construction Of Rail Over Bridges

- This year the Government of Assam intends to convert 1000 of these timber bridges into permanent RCC bridges and for this purpose Rs. 100 crores have been allocated in the current budget.
- Further with the active support and help of the Ministry of Railways, Government of Assam has identified 48 such places where Rail Over Bridges can be constructed with 50% state share.
- Accordingly, Rs. 50 crores has been allocated for this purpose so that the works can be taken either by Railways or PWD(R) as per the feasibility and at mutual convenience.

#### **Tea Garden Workers Financial Inclusion**

- In the last couple of months, Government of Assam has opened over 6.50 Lakh number of bank accounts for tea garden workers and this has strengthened our resolve further to improve their financial inclusion.
- To drive the Financial Inclusion of Tea Garden workers further, the Government of Assam proposes to pay Rs 5000/- to each tea garden worker in his or her bank account. Initially, Rs. 2500/- to each workers who have opened bank account and subsequently another Rs 2500/- will be paid to them if the wages are received through the Bank account continuously for six months and for this purpose Rs 287 crores have been set apart in this budget.

#### Wage Compensation For Pregnant, Temporary Workers Of Tea-Gardens

- For better health and nutrition of the Pregnant, Temporary Workers of the Tea-Gardens, Government of Assam will introduce a system of onetime payment of Rs. 12,000 to each pregnant woman of garden areas so that she can better look after herself and her unborn baby without compromising the livelihood of her family.
- **¤** The Government is hopeful that this initiative will bring down the high MMR and IMR of garden areas.

#### Setting Up Pravasi Asomiya Department

- H The Government of Assam proposes to set up a new Department namely, Pravasi Asomiya Department very soon so as to provide a platform for the substantial number of Assamese diaspora settled in various countries.
- This will help to their roots in the State and help facilitate interaction with the Government and other stakeholders and contribute to the trade, business and in other walks of life.

#### Deen Dayal Divyang Sahajya Achani

- As part of Government of Assam's mission to reinvent the Social Welfare Department, it proposes to provide Rs. 5000 for the medical treatment of each of 4, 50, 000 Divyangs in the State.
- The scheme is dedicated to Pandit Deendayal Upadhaya and hence this flagship program is named as "Deen Dayal Divyang Sahajya Achani".
- × Accordingly, Rs. 250 crore has been allocated in the current budget and any additional amount required for the scheme will be provided in due course of time.

#### **Urban Housing**

- We have taken up steps for large scale construction of houses in urban areas under the National Flagship Programme,
  "Pradhan Mantri Awas Yojana Housing for All" and eight towns viz. Guwahati, Nagaon, Silchar, Dibrugarh, Tinsukia, Jorhat,
  Kokrajhar and Dhubri are being covered as per the guidelines of the Central Government.
- In order to help the poor and the homeless, the Government of Assam has decided to give a subsidy of Rs 50,000 to each beneficiary in addition to the other benefits already provided by the Ministry of Housing and Urban Development.
- **For this purpose, and for this purpose Rs. 100 crores have been allocated in this budget.**

### Budget 2017-18: A Summary

#### **Finance Department**

- **Swift receipt of Rs, 1450 crores as Oil Royalty Arrears.**
- × New Assam Treasury Rules, 2017 put in place from 1st of April 2017 in place of existing Rules of 1937
- × New Excise Rules made effective from 1st of September 2016.
- More than 6 lakh bank accounts opened for tea garden workers in a record time.
- Exempted POS machines, ATMs, brand band equipment etc. from entry tax till the end of financial year 2016-17 to facilitate digital transactions.
- All employees including Muster Roll (MR) & Work Charge (WC) employees will now get salaries & wages monthly as other regular employees.
- × Retention of posts have been simplified and no retention would be required except for contractual and MR and WC personnel.
- **Ceiling (FOC)** has been made online from 1st of July 2016 as promised.
- x Suo-moto FOCs made effective and a sum of Rs 1179 crore already released suo-moto.
- Out of 25 new Treasuries proposed, one Treasury made functional and 17 number of treasuries are under consideration by RBI and AG office.
- Process of installation of CCTVs in major Treasuries is in progress.
- **x** SMS alert to DDOs and Payees on clearance of bill by Treasuries has been activated.
- **E-Kuber Platform of RBI has already been started on a pilot basis in two treasuries.**
- H Comprehensive and updated Delegated Financial Powers Rules issued in August 2016 after a gap of 17 years.
- Departments have utilised Rs. 9348.16 crore till 31st of December 2016 against Rs. 6584.20 crore during the corresponding period of previous year, which is about 42% more than previous year.
- Expenditure targeted not less than 60% of the total plan allocation by February 28th, 2017 against an annual achievement of 37% in 2015-16.
- Plan to expand the online ceiling system in such a way that the moment Finance Department issues ceiling, the last point in the chain, i.e., DDO in the concerned department shall receive the ceiling instantly will be implemented in the financial year 2017-18
- Project proposal in the name of ASPIRe (Assam State Public Finance Institutional Reforms) with the assistance of World Bank at a project cost of 44 million US dollars slated to start from May 2017. The project will cover all aspects of financial management including strengthening the systems of Taxation, Excise Departments and budgetary controls with treasury management.
- Setting up of Cash and Debt Management Cell to ensure proactive cash flow and for tapping of cheaper options for borrowings.
- Target to increase expenditure in the first three quarters and ensure that the last quarter spending does not go beyond 30% over the period of next three years.
- First budget prepared without the Plan and Non-Plan classification/ head and now budget has only Capital and Revenue Heads.
- All salaries are bucketed under the head "Establishment Expenditure" instead of Plan and Non-Plan Head. Everyone will now receive his salaries and wages regularly.

#### **Planning & Development Department**

- Role of Planning & Development Department is being redefined and this Department will be rechristened the "Department for Development and Transformation of Assam (DDTA)".
- State Planning Board renamed as State Innovation and Transformation Aayog (SITA) and to play a key role similar to NITI Aayog. SITA has already identified specific areas for conducting the studies which include the Revival of Tea Industry, Skill Development, Revival of Sick Industries and Sustainable Management of River Brahmaputra.
- Constitution of a Commission consisting of a Retired Chief Secretary to consult all the councils including the Non-Sixth Schedule areas and recommend a new methodology for devolution of funds to the Karbi-Anglong, Dima Hasao and BTC, as there is no plan fund now.

#### **Stakeholder Consultations**

- Rs.1000 crore earmarked for the various projects suggested by Hon'ble MLAs of all political parties.
- Z7. Suggestions received from various stakeholders of the society on matters like Public Paddy Procurement, Playgrounds in every village, regularisation of a large number of contractual TET teachers etc. have been included in the budget proposals for 2017-18.

#### **Employee Benefits**

- Recommendations of 7th Assam Pay and Productivity Pay Commission have been accepted by and large and will be implemented from 1st of April 2016.
- H Government will pay the arrear of Rs 2200 crore from 1st April 2016 in installments. The first instalment of the arrears will be released immediately in April-May 2017 and the balance arrears will be paid within the fiscal 2017-18.
- All Government employees to get housing loan at a very low interest rate of 5.05% without any collateral security up to a limit of Rs. 15 lakhs.
- Scheme announced for higher education loan for the children of all State Government employees up to an amount of Rs. 10 lakhs at 4% interest with the State Government bearing the rest of the interest component.
- Compassionate appointment policy to be revisited in consultation with stakeholders to allow immediate dependent of the deceased employee to draw the last drawn salary of the employee without seeking any job till the date of retirement had the
- x employee, been alive.
- All State Govt. employees to get reimbursement of Rs.1000 on buying two Khadi apparels every year.
- Retention procedure for all posts abolished to ensure regular monthly payment of salaries to all categories of employees.

#### Home Department

- Amount of Rs.125.00 Cr allotted to Mission MOITRI Thana based system reform programme covering 62 thanas.
- × Additional Police personnel to be recruited and total new recruitment will be 8993.
- **z** (Two) nos. of new IR Battalions to be raised.
- Police Training College in Dergaon to be upgraded as Assam Police Academy at par with global standards.
- It introduce E-Challan system to make police force mobile, responsive and tech-savvy with in Kamrup (Metro) and 10 other districts in 2017-18.
- H Rs.5.00 Cr allocated for establishment of Traffic Signal System across 99 in Urban Centres in Assam.
- Rs.2.00 crore is allotted for Cyber Dome project to increase the technical intelligence gathering capabilities of the state using cutting edge technology and trained manpower. It will also include cyber security, cyber forensics and social media monitoring cell.
- It is build a Police Memorial in Guwahati to perpetuate the hallowed memory of their saga of gallantry, valour and ultimate sacrifice of the security personnel.
- **H** To establish a Police Sub-Division at Umrangso considering the anticipated rapid growth of this area.
- Rs.2.00 crore has been earmarked for a complete revamp of the infrastructure and equipment for Forensic Science Laboratory.
- x 36 new Fire Service Stations notified by the Government and 6 new stations recommended by DRSC to be operationalized.

#### **Border Areas Department**

Border Areas Department" to be renamed as "Border Protection and Development Department".

#### Agriculture Department

- Identity Cards to be issued to all farmers in the State within fiscal year 2017-18.
- x 39,000 Shallow Tubewells to be installed in 2017-18 to increase area under Irrigation.
- lpha To make the name of Majuli as Assam's trade mark of organic products in the name of "O'Majuli"
- × Completion of 200 small irrigation schemes presently in progress.

- Under CAD & WM programme, it is proposed to create 28640 hectors of Irrigation potential by undertaking four more Schemes in the year 2017-18.
- Rs.1000 lakhs earmarked for undertaking Irrigation Schemes through Deep Tubewells (DT) to be powered by Solar Energy under Signature Project.

#### Animal Husbandry and Veterinary: Adding to the farmers' income

- Emphasis on organised milk production through large number of Dairy Co-operative Societies. Financial assistance from the World Bank assisted APART project to be made available for the development of both organised and un-organised dairy farmers.
- x Setting up of a new Veterinary & Life Sciences University covering all Dairy and Veterinary Institutes of the State.
- x Setting up of a Dairy Science College at Sarbhog, Barpeta.
- X Vaccination programmes against the Foot & Mouth disease and other diseases of this kind will be taken up in a comprehensive manner.
- **µ** Insurance of cattle population of the State to get top priority.

#### Fishery: Self-sufficiency is the target

- H Fishery department to implement a 'Fish Seed Bank' Project for which new ponds of 22 hectares in size will be created.
- × A model farm of integrated fish-pig farming will be taken up in Majuli on 10 hectare area.
- Under Rural Infrastructure Development Fund (RIDF), it is proposed to construct 1000 hectares of new Fish Ponds, 430 hectares of village community tanks and four fish markets.
- H Rs.155.58 crore earmarked for Fishery Department for taking up various developmental programmes.

#### Soil Conservation: Conserve the degraded for all-round development

- x Constitution of a Committee to firm up the establishment of a Mini Secretariat in Barak Valley.

#### Secretariat Administration

- Human Resource Management System (HRMS) will be rolled out along with the introduction of File Management System (FMS) in all the Departments in Assam Secretariat.
- Provision of Staff Bus for commuting of Women employees of Assam Secretariat to the Office as a welfare and safety measure
- **Filling up of all 602 numbers of vacant posts in the Secretariat on priority.**

#### Information and Public Relation

- Released about Rs. 22 crores till 31st January, 2017 to clear the huge pending bills lying unsettled from the past.
- Introduced an obligatory ceiling system for this purpose to release Rs. 1.4 crores every month without going through normal ceiling procedures.
- E Constitution of 'Journalist Family Benefit Fund' for providing suitable financial assistance to the bereaved family members of journalists who may lose their lives while in service due to various reasons.
- Media fellowship of Rs. 50,000 (Rupees fifty thousand) to selected journalists for pursuing higher studies in the relevant field of journalism.
- Journalists' Pension to be introduced for the financial security of respected journalists after retiring from the profession on the lines of "literary, artists and sports" pension from 2017-18 onwards.

#### Judicial Department

- Construction of new Judicial Court Buildings in Mangaldoi, Gohopur, Bilashipara, Sadia, Udlaguri, Hajo, Kamrup (Amingaon) and Dhubri.

- In eight districts, Mouzadar system will be introduced in place of existing Tahsildari system.
- Sale permission will be made online and time bound. Land revenue activities will be made online in an integrated manner. Mouzas will be computerized. Collection of land revenue will be monitored online.
- IO1 new areas identified for extraction of Sand shall be expedited for commission so that it will fetch estimated additional revenue of Rs. 45 crore.
- To exempt luxury tax in respect of hotels and lodging houses, including home-stays, providing residential accommodation in rural areas.
- To exempt 50% entertainment tax for a period of three years to Permanent multiplexes.
- To redue cess on green tea leaf from 15 paise per kg to 10 paise per kg under the Assam Taxation (On Specified Lands) Act.
- **To exempt the women SHGs from stamp duty for documentation related to Bank loan upto Rs. 2.5 lakhs.**


## **Budget Glossary**

Budget - A budget is a statement of allocation of (scarce) resources to achieve government's objectives for a specific time period. It is a financial plan for how the Government will receive and utilize resources (funds) in a particular fiscal year.

A Budget supports better accountability in the use of public funds; and helps in the prioritization of public functions to which scarce resources require immediate allocations.

The major components of a budget are:

- **Revenues: Funds that are raised through various means.**
- Expenditure: Funds used for spending on day to day expenditure and specific programs including capital projects.



## **Structure of Government Accounts**

Consolidated Fund	All revenues received by the Government including tax and non-tax revenues, loans raised and repayment of loans given (including the interest thereon) form the Consolidated Fund. All expenditure and disbursements of the Government, including release of loans and repayments of loans taken (and the interest thereon), are met from this fund.
Contingency Fund	The Contingency Fund is in the nature of an imprest, intended to meet unforeseen expenditure, pending authorization by the Legislature. Such expenditure is recouped subsequently from the Consolidated Fund. The corpus of this fund for the Government of Assam is INR 100 crores.
Public Account	All public moneys received, other than those credited to the Consolidated Fund, are accounted for under the Public Account. In respect of such receipts, Government acts as a banker or trustee. The Public Account comprises: repayable like Small Savings and Provident Funds, Reserve Fund, Deposits and Advances, Suspense and Miscellaneous transaction (adjusting entries pending booking to final heads of account), Remittances between accounting entities, and Cash Balance.

## Types of Deficits

Deficit	Refers to the gap between Revenue and Expenditure. The kind of deficit, how the deficit is financed, and application of funds are important indicators of prudence in Financial Management.
Revenue Deficit / Surplus	Refers to the gap between Revenue Receipts and Revenue Expenditure. Revenue Expenditure is required to maintain the existing establishment of Government and ideally, should be fully met from Revenue Receipts.
Fiscal Defi <mark>cit /</mark> Surplus	Refers to the gap between Total Receipts (excluding borrowings) and Total Expenditure. This gap, therefore, indicates the extent to which expenditure is financed by borrowings. Ideally, the Borrowings should be invested in capital projects.

# Types of Receipts

Tax Revenue	Comprises taxes collected and retained by the State and State's share of Union taxes under Article 280(3) of the Constitution.
Non-Tax Revenue	Includes interest receipts, dividends, profits etc.
Grants-in-Aid	Essentially, a form of Central Assistance to the State Government from the Union Government. Includes 'External Grant Assistance' and 'Aid Material and Equipment' received from foreign governments and channelized through the Union Government. In turn, the State Governments also give Grants-in-aid to institutions like 6th Schedule Councils, Panchayati Raj Institutions, Autonomous Bodies etc.
Capital Receipts	These are loans raised by the Government from the public (these are termed as market loans), borrowings by the Government from the Reserve Bank of India and other parties through the sale of Treasury Bills, the loans received from foreign Governments and bodies, disinvestment receipts and recoveries of loans from State and Union Territory Governments and other parties.

Expenditure is classified as Revenue Expenditure and Capital Expenditure.

Revenue expenditure - to meet the day-to-day running of the Government departments and for rendering of various services, making interest payments on debt, meeting subsidies, etc.

Examples of capital expenditure are acquisition of assets like land, buildings, machinery, equipment, investments in shares, etc.

In this budget, with the merger of the Plan & Non-Plan heads, we have introduced new expenditure classifications as listed below:

Estimated Resource Pool	Consists of the Central Devolution, State's Own Tax & Non-Tax Revenue and Other Sources of Revenue including Borrowing etc.
State Funding for Priority Development (SFPD)	Consists of the Estimated Resource Pool excluding the former Non-Plan Expenditure (Now called as Establishment Expenditure etc.)
State Own Priority Development Schemes (SOPD)	Former State Plan schemes which include schemes taken from State's Own Resources, State Share for Centrally Sponsored Schemes/ NEC/ NLCPR/ RIDF counterpart funding for EAP etc., allocations to 6th Schedule Councils, TSP and SCSP.
