- 8. Bills pertaining to municipality taxes, water and electricity for the building should be regularly paid and updated.
- 9. The space should be made available initially for a period of 3 years which may be further extended for 2 more years.

The following are the provision expected in the Office Space:

- 1) Small Reception cum Security area at the entrance with a waiting area for 4-5 person
- 2) 2-3 Breakout room which can be utilized as single room for sr officers.
- 3) Training Room with State of Art Infrastructure with sitting capacity of 30 persons, Training room should have provision for Laptop/Computer, Over Head Projector, Sound and Acoustics, Other training implements etc. Attached adequate wash room for both male/female
- 4) Conference hall with projection facility and LED TV with sitting capacity of 20 persons
