This Department's letter No.No FSI 5/2005/Pt II/35 Dated: 31/5/2016

Sir/Madam,

I am directed to request you to refer to the letter cited above and to say that the Finance (SIU) Department had extended the validity for filling up of essential vacant sanctioned posts approved by Finance (SIU) Department since 2012-13 up to 31st March, 2017. However, a number of Departments have now moved Finance Department for further extension as the processs of appointment in these Departments could not be completed within the stipulated time for various reasons.

2. In view of above, it is now decided that the approvals already accorded by Finance (SIU) Department for the years 2013-14, 2014-15, 2015-16, 2016-17 and 2017-18 shall be extended for a further period up to 31st March, 2018. Approvals for filling up of vacant sanctioned posts issued for these years shall remain valid up to 31st March, 2018 and automatically lapse thereafter.

All Departments are requested to complete the process for filling up of the vacant sanctioned posts already approved by Finance (SIU) Department during 2013-14, 2014-15, 2015-16 2016-17 and 2017-18 accordingly by 31st March, 2018.

- 3. However, Departments may furnish specific proposal for extension of validity of Approvals issued by Finance (SIU) Department during 2006-07, 2007-08, 2008-09, 2009-10, 2010-11, 2011-12 and 2012-13 in cases where the posts could not be filled up due to Order of Hon'ble Courts or non-completion of APSC process with justification and copy of Court Orders etc.
- 4. Further, all Departments are also requested to examine if any posts, which have been lying vacant for long time, and lost their utility, can be abolished and submit proposal to concerned Expenditure Control branch of Finance Department as per procedures.
