## OFFICE MEMORANDUM

Confusion has arisen amongst most of the D.D.Os regarding fixation of revised pay as per Assam Services (ROP) Rules, 2017 in cases where financial benefits were granted as per the earlier Assured Career Progression Scheme (ACPS). As per the A.C.P. Scheme, financial benefits were granted either by providing higher Grade Pay or by granting increment where the Grade Pay was highest in the Pay Band.

After careful consideration the Govt. has decided to clarify the fixation on 01-04-2016 or any subsequent date as per option furnished by the incumbent, shall be made on the basis of the pay drawn by the concerned incumbent including the financial benefit, as per the table relevant to his/her original Grade Pay. An illustration is given below:

Say, an employee in the pre-revised Pay Band 2 (Rs.5200 - 20200) with Grade Pay of Rs.3000/- was granted financial benefit by grant of a higher Grade Pay of Rs.3100/-. Before coming to revised pay structure as per ROP,2017, his pay in the revised pay structure shall have to be fixed as per table 1.11 where the original Grade Pay was Rs.3000/-. Similar will be the case where 2(two) financial up-gradations were allowed and also where increments were granted under A.C.P.S.

In cases where A.C.P.S. were granted after 01-04-2016 but before publication of this rule, such employees, may opt to get their revised pay fixed on the date of from which the A.C.P.S. was granted. In such a case, the revised pay of the employee will have to be fixed under Rule 5 of the Notification No.FPC.1/2017/Pt./2, dtd.17-03-2017.
