## **NOTIFICATION**

Government of Assam is rolling out GRAS (Government Receipt Accounting System) <u>https://assamegras.gov.in</u> which will serve as the common collection portal for the State of Assam and would be linked with Cyber Treasury under Directorate of Accounts and Treasuries for receiving payments electronically.

In this regard, it is to inform that after successfully testing with some departments and subsequent clearance of security audit a soft launch of GRAS is planned for 1<sup>st</sup> July 2018. The departments having their functioning portal will be linked to GRAS portal using (portal to portal integration) and other departments may directly use GRAS portal to facilitate payment against the various services offered by them

It has been decided that Commissionerate of Excise, Directorate of Geology and Mining and Directorate of Finance (Economic Affairs Department) will be on-boarded from 1<sup>st</sup> July 2018 and will have to mandatorily make all collections using GRAS portal only. The same will be rolled out to all other departments facilitating collections and a formal launch will be done subsequently. Departments are hereby requested to provide necessary support to the GRAS technical team. Necessary capacity building and training will be provided by the GRAS technical team.

Cyber Treasury Officer (CTO) will be responsible for approval, reconciliation and submission of accounts to AG and will closely monitor all functionalities of GRAS in addition to other related activities.

System Admin, DoAT (Directorate of Accounts and Treasuries) will be responsible for making necessary system level administrative changes upon request received from concerned departments.
