With reference to above, I am directed to state that after due examination of records and medical reports it appears that Smti. Gita Nath is suffering from hearing impaired since her birth and also manifested before the death of her father Late Phatik Ch. Nath, Ex-U.D.Asstt. who died on 12.12.1989. Also, the lifetime family pension has been allowed only after the death of Smti. Parul Devi, w/o Late Phatik Ch. Nath and mother of Smti. Gita Nath i.e from 22.1.2014 i.e. long after issuance of Govt. Notification No.PPG(P) 268/95/85 dtd. 30.5.2003, which is not retrospective. Moreover, before her demise, Smti. Parul Devi, w/o Late Phatik Ch. Nath had submitted prayer for sanction of lifetime family pension in favour of her unmarried physically handicapped daughter Smti. Gita Nath to Govt. on 15.12.2012.

You are therefore requested to grant life time family pension to Miss Gita Nath, daughter of late Phatik Ch. Nath, Ex-U.D.Asstt. in the office of Superintendent of Taxes (now Asstt. Commissioner of Taxes), Barpeta Road, who is physically challenged (hearing impaired-50%) w.e.f. the death of her mother, Parul Devi on 22.1.2014 in terms of Rule-143(C) of the Assam Services (Pension) Rules, 1969.
