## Minutes of the High Power Committee meeting held on 11/05/2017 under the Chairmanship of Sri V.B.Pyarelal, I.A.S. Additional Chief Secretary to the Govt. of Assam, Finance Department on RIDF Projects

- 1. The High Power Committee (HPC) meeting on RIDF was held in the Conference Room of Finance Department, Block-F, Ground Floor to review the status of implementation of RIDF Projects under the Chairmanship of Sri V.B. Pyarelal, I.A.S. Additional Chief Secretary to the Govt. of Assam, Finance Department. The meeting was attended by other officers of Finance and implementing line departments, CGM, NABARD and other officials of NABARD. The list of members present is appended herewith.
- 2. At the outset, the Chairman welcomed the members present and requested Director, Finance (Economic Affairs) Department to explain the purpose of the meeting.
- 3. With the permission from the Chairman, the Director, Finance (Economic Affairs) Department explained the objective of the meeting and stated that some line departments do not issue A/A in time, as a result of which the entire implementation process gets delayed. He also indicated that slow moving and non starter projects are also areas of concern and requested the departments for submission of drawals timely and update the NABARD site regularly for smooth monitoring of the implementation of the RIDF projects.
- 4. The HPC made threadbare discussion on the projects department wise and arrived at the following decisions:
  - a) Fisheries Department was asked to issue A/A within a week for the balance 17 no. projects sanctioned by NABARD under RIDF-XXI.
  - b) It was also observed that as regards Non-Starter & Slow Moving Projects, there are mismatch of statistics between NABARD and implementing line departments concerned. The HPC instructed Cooperation, Irrigation, PWD, Soil Conservation, Fisheries, Sericulture, Industries and Commerce, WRD and AH & Veterinary Department to submit the latest status on Non-Starter & Slow Moving Projects alongwith justification note for delay to Finance Department as well as NABARD, and asked all line departments to update the Google site of NABARD regularly.
- c) All line departments concerned were also requested to nominate a Nodal Officer for RIDF matters and to furnish the e-mail ID and contact no of the Nodal Officers to Finance Department and NABARD.
- d) As requested by the CGM, NABARD, HPC decided to raise the matter of inclusion of sports as one of the items of RIDF in the ensuing BoD meeting scheduled on 26/05/2017 at Guwahati.
- e) All line departments were also asked to submit proposals for release of fund if the works are in progress furnishing relevant supporting documents along with the proposals.
- f) The HPC meeting also decided to conduct a review meeting of Nodal Officers of the line departments concerned so as to review and find out the actual status of the implementation of the projects.

- g) Irrigation and Fisheries Department were asked to give PowerPoint Presentation in the next HPC meeting highlighting the present status of the implementation of RIDF projects taken by the departments.
- h) The Chairman HPC indicated that sector-wise allocation for RIDF-XXIII would be accorded in the next HPC meeting.
- 5. The CGM, NABARD requested Finance Department, to submit new warehouse proposals for sanction under WIF. She also proposed for exposure visit under Rural Infrastructure Promotion Fund (RIPF) during the current financial year for which implementing departments were requested to submit suitable project proposals under RIPF.
- 6. At the end, Addl Chief Secy., Finance Department requested all implementing line departments for timely submission of PCR & drawal proposals and to update Google site of NABARD regularly for proper monitoring.
- 7. The meeting ended with vote of thanks to the Chair.
