**ORDER.**

**In pursuance** of this Department's letter no FEC(1)130/17/12 dated 15<sup>th</sup> February, 2018 issued by SPIO & Deputy Secretary to the Government of Assam, Finance (EC-I) Department, regarding hearing on the RTI Appeal petitions, filed by Shri Dulal Bora, a resident of Koinadhara Tiniali, House No - 118, Khanapara, Guwahati-781022, District-Kamrup (M), Assam, Shri Dulal Bora, remained absent before the 1<sup>st</sup> Appellate Authority, Finance Department, in my office chamber, today i.e 23<sup>rd</sup> February' 2018. SPIO confirmed that he issued the letter through Secretariat issue Branch and obtained receipt from issue

In the 1<sup>st</sup> Appeal Petitions, filed by Shri Dulal Bora, as stated in details, in this Department's letter under reference dated 12<sup>th</sup> January 2018, he has enclosed copy of Allegation petition, copy of RTI application, as reported to the undersigned by the SPIO, Finance (EC-I) Department.

1<sup>st</sup> Appeal Petition No. D.B.56089/17/R/1 dated 12/01/18

**SPIO, has received original RTI petitions, details as shown in the statement enclosed signed by SPIO.**

Immediately on receipt of the RTI petitions No.D.B.54884/17(R), dated 10/10/2017 along with the copy of Allegations petitions were put up in file, by SPIO. Then wrote a letter vide No.FEC(I).130/2017/4 dated 17/10/2017 (Annexure-I) to Dulal Bora stating that Finance (EC-I) Department has not received the earlier allegation letter No. D. B. 998/7/17, dated 11/7/2017 which is enclosed with his RTI application, hence it is informed as, that there is no information to furnish him by this Finance Department, however also informed that the allegation letter as enclosed with the RTI petition is not related to this Finance (EC-I) Department.

Further Finance Department RTI petition No. D.B.-54884/1/7(R), dated 10/10/2017 along with allegation letter has been forwarded to the WPT & BC Department vide letter No.FEC(I).130/2017/05 dated.17/10/2017 (Annexure-II) for taking necessary action as per rules and to furnish the required information to the applicant directly after taking necessary action and the same letter had been copied to applicant Sri Dulal Bora.

**On receipt of 1<sup>st</sup> Appeal Petition following action has been taken.**

Immediately on receipt of the Appeal petitions along with copy of RTI, Petitions and copy of Allegations petitions were put up in file by SPIO. A meeting was called with SPIO, Finance (EC-I) Department along with applicant Sri Dulal Bora, vide this office letter FEC(I).130/17/12 dated 15/02/2018 (copy enclosed at Annexure-III) on 23<sup>rd</sup> February' 2018 in the Office Chamber ( Room No. F-004, F'Block Ground Floor, Dispur-06, at 11am.

At the time of hearing Sri Makibar Rahman, Deputy Secretary & SPIO, Finance (EC-I) Department was present on 23<sup>rd</sup> February' 2018 at 11am but Sri Dulal Bora, the applicant was absent on 23<sup>rd</sup> February' 2018 at 11am on the scheduled venue.

Since Shri Dulal Bora, the Applicant was absent on 23<sup>rd</sup> February' 2018 at 11am to ensure reasonable and sufficient opportunity, for the ends of natural justice and to make his submission before the undersigned, notices were issued by SPIO & Deputy Secretary, Finance (EC-I) Department, for hearing again on 8<sup>th</sup> March at 11:00 AM, vide letter no FEC (1)130/17/13 dated 28<sup>th</sup> February' 18 (Annexure-IV). But the applicant Sri Dulal Bora was again absent on 8<sup>th</sup> March at 11:00 AM.

Heard SPIO. He stated that the contents of the Allegations do not come under the purview of Finance Department. The same is the case in respect of the RTI Petitions. The information is not available with the Finance Department. So SPIO and ASPIO of Finance Department are not in a position to furnish the

relevant information. The Allegation petition, had been received by the Department already forwarded to the concerned Administrative Department, where the information are likely to be available

In conclusion, it is ordered as follows, except as per Govt Om, cited below.

(1) Wherever the information is available, SPIO / ASPIO will furnish the required information, as per provision, of RTI, ACT.

(2) If the information is not available with the SPIO, ASPIO, he will take necessary action as per section 6(3), of the RTI act. ELSE, SPIO/ASPIO, will forward the same to the concerned PIO/SPIO of the concerned administrative department where the information is likely to be available.

(3) Factual report should always be intimated to the Applicant, as per RTI, provision.

In the instant RTI, petitions, under reference, SPIO, ASPIO has confirmed the information is not available,

(3) Shri Dulal Bora is at liberty to submit copy of the RTI, Application before the concerned PIO/SPIO, of the concerned administrative department where he thinks and satisfied that the information is likely to be available. It is expected the PIO/SPIO on receipt of such petitions from Shri Dulal Bora, will dispose of the RTI, Petitions as per provision of the RTI ACT, 2005.

This disposes of RTI petitions filed before the 1<sup>st</sup> APPELLATE Authority, of the Finance Department. If, any other RTI, Application filed before the 1<sup>st</sup> Appellate authority, is pending and is of similar nature, it also stands disposed of, and similar action will be taken, accordingly.
