Bidders will be required to deposit a security amount of INR 20,000.00 in the form of demand draft in favor of **Project Director, AS-CFMS, Finance Department, Govt. of Assam** for participating in this auction which need to be enclosed with the technical envelope. This security amount will be refunded after 15 days of the completion of the auction or after completion of possession of the items by the successful bidder, whichever is later.
3. The bidders must quote the price per unit for each item in the format specified in Annexure-II, as the quantities listed in the table may vary. Regardless of the quantities mentioned in their financial bid, the bidder must take possession of all the items available on the day the bid is opened.
4. In the financial evaluation of the quotations, the total unit price will be considered for selecting the highest bidder. However, the total value will be calculated manually based on the actual number of items available on the day the bid is opened.
5. The quoted amount in the financial bid must be inclusive of all taxes.
6. Selected bidder will be required to make the full payment in the form of demand draft in favor of **Project Director, AS-CFMS, Finance Department, Govt. of Assam** before signing of the auction contract for taking possession of the auctioned items to be issued from AS-CFMS, Finance Department, Govt. of Assam.

8. The selected bidder must take possession of the items within 7 days of issuing the order. If the selected bidder does not take possession of the auctioned items within the stipulated time or withdraw the quotation, the security deposit will be forfeited without any notice. In such a case, the bidder with the second-highest quotation will be selected, and the contract will be signed at their quoted price. Similarly, the security deposit of the second bidder will be forfeited if they also fail to take possession within the required timeframe or withdraw the quotation.
