Subject: Clarification regarding sanction of Grants-in-aid as per Rule 25 of Delegation of Financial Power Rules, 2022.

In order to expedite the implementation of Schemes in smooth manner sanction of Grants in aid proposals by the Administrative Departments under Rule 25 shall take place in the following manner:

Sl. No.	Detail Head	AA/FS
1.	31 – GIA (Salary)	All proposals shall come to Finance Department for prior concurrence, except for those under Centrally Sponsored Schemes & Central Sector Schemes and Externally Aided Projects, provided that such proposal shall not create any permanent liability for the State Government beyond the scheme / project period.
2.	32 – GIA (Non-Salary) 33 – GIA (Subsidy) 35 – GIA (Capital Assets) 42 – GIA (Fund for building & Structures) 43 – GIA (Fund for Infrastructural Assets) 44 – GIA (Fund for procurement of Land)	Proposals under SOPD & TG heads shall come to the appropriate level of designated Finance Committee, as per Rule 20.3 read with Rule 21 and Rule 22 of the DFPR, 2022, for prior concurrence. Proposals under EE head shall come to Finance Department for prior concurrence.

All Externally Aided Projects shall continue to be governed as per Sl. 138 of Schedule of Power to Sub-ordinate Authority under DFPR, 2022. All Centrally Sponsored Schemes & Central Sector Schemes shall continue to follow Sl. 135 of Schedule of Power to Sub-ordinate Authority under DFPR, 2022.
