**EXECUTIVE ORDER**

**Subject : Clarification on the Retirement age of employees conferred with "Lok Sewa Puraskar"**

Whereas; the Government of Assam in recognizing the exemplary work of the non-gazetted employees of the State Government has introduced Lok Sewa Puraskar for both District and State Level with award of a one year extension of service and,

Whereas; the Notification No. FEG.1/2005/27 dated 05-04-2008 read with the provisions of FR 56(a) of FRs & SRs set forth the age of compulsory retirement on superannuation of a Govt. Servant at 60 (sixty) years.

Therefore, in synchronisation with the award and rule position, in partial modification of the Clause(3) in OM No. FSI.17/2022/10 dated 14-12-2022, it is clarified that, the State Govt. employees conferred with Lok Sewa Puraskar shall be re-employed for a maximum period of 1(one) year beyond the date of superannuation i.e. on attaining the compulsory retirement age of 60 (sixty) years. However, regarding the felicitation to the awardees with the citation and the cash award, the same shall remain unchanged in the clause.

During the period of such re-employment, their designation shall be Lok Sewa Awardee and the re-employment shall be made against separate post to be created for the period of re-employment which shall be personal to the incumbent.

During the period of the re-employment, Lok Sewa Awardees shall not be entitled to annual increment or any promotional benefit and the period of re-employment shall not be counted as qualifying service for the purpose of pension & pensionary benefits.

Under no circumstances, in-service promotion of any employee should be allowed to be affected due to re-employment of Lok Sewa Puraskar Awardees

The other terms & conditions as laid down in OM No. FSI.17/2022/10 dated 14-12-2022 & No.E -299720/01 dated 29-05-2023 remains unchanged.
