NOTICE INVITING TENDER

Office of the Project Director, ASCFMS Government of Assam, invites sealed bids under single bid system i.e. Techno commercial from the interested bidders for auction of old / obsolete/CPU's, , Printers, Used Cartridges, Almirah, monitor, etc. on "As is where is basis " stored at Finance Department.

A. General:

AS-CFMS

1. Qualification criteria:

- a. The bidder should have been registered with state Goods and Services Tax (GST). Copy of such certificate shall be enclosed as a proof.
- b. Registration certificate of bidder under any suitable act e.g. shop and Establish Act, Company Act, Partnership Act etc. Copy of such certificate shall be enclosed as a proof.
- c. Self-attested copy of PAN card.
- d. Self Declaration compliance of E-waste (Management and Handling)Rules,2011,Batteries (Management and Handling)Rules,2011

2. **General Terms& Conditions:**

- a. The bidders may inspect the items on predetermined dates and satisfy themselves about the items they are bidding for, as the items condition is on “ As is where is basis”.
- b. The items shall be offered to the bidder quoting highest price.
- c. The successful bidder shall be required to lift all the items from the disposal site to its premises within 3(Three) days after the payment of the quoted amount. On failure to do so, ASCFMS shall have the right to forfeit the entire amount of the bidder and dispose the items to alternate bidder.
- d. Successful bidder has to submit an undertaking that the firm will ensure prevention of leakage of government data stored in obsolete devices if any.
- e. Each page of tender document should be signed by the bidder (s)
- f. Incomplete and unsigned quotations are liable to be rejected.
- g. Total Quotation price on letter head of the firm - Annexure A
- h. Detail list of item to be disposed is at Annexure-B

3. **Bid Price**

- a. The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and re writing.
- b. All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- c. The rates quoted by the bidder shall be fixed for the duration of the

contract and shall not be subject to adjustment on any account.

d. The Prices should be quoted in Indian Rupees only.

4. Submission of Bids:

- a. A bidder shall submit the quotation in one sealed envelope only as per format.
- b. Sealed Bids shall be received, not later than 20/12/2022.upto 3.00 P.M No Bids will be accepted after this date & time under any circumstances. This office will not be responsible for any postal/courier delay and also for reasons beyond the control of this office.
- c. Envelope containing quotation must bear on the cover itself, name of item bidding for, name and full address with phone numbers of the bidder.

5. Opening of Bids:

- a) Techno Commercial bids will be opened after scheduling time, date and venue in the presence of the bidders' representatives who choose to attend.
- b) The bidders' representatives who will be present shall sign in the designated register/ attendance sheet evidencing their attendance, In the event of the specific bid opening being declared a holiday for the purchaser, the bid shall be opened at the same time and location on the next working day.
- c) The Condemnation Committee formed in Finance department in this regard will evaluate and compare the quotations determined to be substantially responsive i.e. which are properly signed; and conform to the terms and conditions.

6. Validity of Bid

The bid shall remain valid for a period not less than 60 day after the deadline date specified for submission.

7. Award of contract

7.1 The contract will be awarded to the bidder whose quotation has been determined to the substantially responsive and who has offered the highest evaluated quotation price.

7.2 Notwithstanding the above, AS-CFMS reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award

of contract.

7.3 The bidder whose bid is accepted will be notified of the award of contract by ASCFMS prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

8. **Payment Terms:** The successful bidder has to submit the bid amount through Treasury Challan in appropriate Head of Account "0070-Other Administrative Service-06-Other-800-0000-000-00-00- Other receipt" **within 3 three days after confirmation**, failing which the offer will be cancelled.

A copy of the Treasury Challan in Original should be submitted to Finance Department for hand over the Condemned materials and after verification, the materials will be released.

9. **Dispute Resolution:** ASCFMS and the Purchaser i.e. bidder shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.
