**ORDER**

Whereas, while Shri Rajat Subhra Bhattacharjee, AFS (Retired) was working as the Senior Finance & Accounts Officer, Directorate of Social Welfare, Assam, he was arrested on 27/02/2017 against the ACB PS Case No. 19/2016 U/S 120(B)/468/420/409, IPC R/W Sec. 13(1) (D)/13(2) of PC Act, 1988.

Whereas, Shri Rajat Subhra Bhattacharjee, AFS (Retired) was placed under suspension w.e.f 27/02/2017 i.e from the date of his arrest, vide Notification No. FEB.94/2017/22 dated 01/04/2017. He was reinstated in service vide Notification No. FEB.61/2020/57 dated 18/09/2020.

Whereas, a Memorandum of Charges was issued against Shri Rajat Subhra Bhattacharjee, AFS (Retired) vide No. FEB.94/2017/247 dated 30/05/2022.

Whereas, Hon'ble Gauhati High Court, vide order dated 12/05/2023 in Writ Petition No. WP(C) 1065/2023, had set aside the memorandum of charges issued vide No. FEB.94/2017/247 dated 30/05/2022 and directed to take necessary steps for finalizing his pension and release of any other retirement dues.

Whereas, the following pensionary benefits have been granted to him, namely - Provisional DCRG vide No. 302332/158 dated 13/08/2023, Provisional Pension vide No. FEB.218/95/246 dated 25/03/2022 and GIS Savings Fund vide No. 266786/458 dated 19/08/2023. For grant of Leave encashment benefit against unutilized earned leave in respect of Shri Rajat Subhra Bhattacharjee, AFS (Retired) communications have been made with the office of the Accountant General Assam.

Whereas, the process of submission of pension proposal of Shri Rajat Subhra Bhattacharjee, AFS (Retired) to the O/o the Accountant General (A&E), Assam, through Kritagyata portal, has already been initiated.

In view of above, the suspension period of Shri Rajat Subhra Bhattacharjee, AFS (Retired) is treated as on duty for all purpose. The Governor of Assam is pleased to direct that under FR 54 B(1)(a), Shri Rajat Subhra Bhattacharjee, AFS (Retired) is entitled to full pay and allowances, as admissible, minus the subsistence allowance already drawn by him for the period under suspension.

Further, under FR 54 B(1)(b), the suspension period of Shri Rajat Subhra Bhattacharjee, AFS (Retired) shall be treated as on duty for pension purpose.

The Departmental Proceeding drawn up in respect of Shri Rajat Subhra Bhattacharjee, AFS (Retired) vide No. FEB.94/2017/247 dated 30/05/2022 is hereby concluded.
