In pursuance of the Workshop on Revised Financial Architecture for Delegation of Financial Power, and in continuation of Office Memorandum No.FEB.129/2021/37 dated 04/08/2021, the following clarifications are issued as reflected below:

- The Notification vide No.FEB.129/2021/37 dated 04/08/2021 is primarily applicable in respect of capital projects under SOPD, Central Sector Scheme, NEC/NLCPR, EAP, RIDF, Centrally Sponsored Schemes and Flagship Social Sector projects. This notification will not be applicable for items of expenditure such as Establishment matters-Salary expenditure, procurement of goods and services etc. For these items of expenditures, existing procedure shall continue.
- 2. General Administration Department and Hill Areas Department are exempted from the purview of this notification.
- 3. For project above Rs.100 Cr, the Administrative Departments will submit the proposal directly before the Cabinet without routing it through the Special Standing Finance Committee or Finance Department after observing other necessary formalities like comments from Technical Departments etc.
- 4. In reference to the para 5.1 of the Notification, it was clarified that the Administrative Department can accord approval limited to double the budgetary allocation amount under the concerned head of account in a given year. For subsequent years, administrative approval will vary depending upon the expenditure made against the AAs issued in previous year(s) and budgetary provisions, of the running financial year. Thus the pool of Administrative Approval will not, at any moment, be more than double the budgetary sanction of that year. For example:-

- 5. Revised Estimate / Re-validation / Cost escalation proposals will be approved by the committee which has accorded the original concurrence for AA. But, if the revised amount exceeds the financial power of the committee, then the proposal with all details will be placed before the committee of appropriate level for appraisal.
- 6. If AA has already been given before issue of this notification, the same shall remain valid if otherwise in order. Financial Sanction and Ceiling proposal will be moved as per provisions of this notification.
- **7.** The power of HoD will be conferred to the following officers, only for the purpose of this notification, for smooth implementation of the notification(Dtd. 4th Aug./2021):
 - i. CEO, ASDMA
 - ii. MD, NHM
 - iii. PD, ARIAS Society
 - iv. MD, SSA
 - v. MD, RMSA
- 8. Administrative Department may entrust Senior Financial Adviser of the Department to handhold and guide the Directorates in processing Financial Sanction and Ceiling proposals for a limited period.
- Administrative Department with no Directorate will exercise the power of Directorate for the purpose of this notification only. The Concerned Department will move Finance (Estt-B) Department for issue of notification.

- 10. For Social Sector Schemes (where there is no provision for AA), the concerned Department will obtain the concurrence from committee of the appropriate level before issuing sanction.
- **11.** If any Department faces any difficulties in implementation of this notification then the Department may continue with the existing system for 2 (two) months i.e., upto 31/10/2021.
- **12.** This notification dated 4th August, 2021 will come into force with effect from 1st September, 2021.
