ORDERS BY THE GOVERNOR  
NOTIFICATION

No. 468309/5: Whereas, a report has been received from the Superintendent of Police, Directorate of Vigilance & Anti –Corruption, Assam vide letter no. DGVA/RC/2024/1915 dated 19/03/2024 stating that Shri Harendra Nath Baishya Bania, AFS was arrested on 18/03/2024 against the ACB PS Case No. 27/2024, under section 7(a) of the Prevention of Corruption Act, 1988 (as amended).

Whereas, it has been stated in the aforementioned report that Shri Harendra Nath Baishya Bania, AFS while serving as Treasury Officer, Kamrup (M) Treasury had demanded bribe from one Shri Samim Ahmed for passing eChallan for depositing money in Govt. Account against purchase of special adhesive stamp.

Whereas, an FIR had been lodged by Shri Samim Ahmed with DVAC and subsequently, Shri Harendra Nath Baishya Bania, AFS was apprehended in Trap operation on 18/03/2024 by the DVAC immediately after he accepted the demanded bribe of Rs. 4,000/- (Rupees Four Thousand) from the complainant.

Whereas, Shri Harendra Nath Baishya Bania, AFS has spent more than 48 hours in custody.

In view of above, the Governor of Assam having been satisfied with the above facts and circumstances and pending drawal of Departmental Proceeding and in exercise of the power conferred under Rule 6 (2) of the Assam Services (Discipline and Appeal) Rules, 1964 places Shri Harendra Nath Baishya Bania, AFS under suspension with effect from 18/03/2024.

During the suspension period, his headquarter has been fixed at Guwahati. The Officer shall in no circumstances, leave the headquarter without prior approval of the Competent Authority.

Shri Harendra Nath Baishya Bania, AFS is allowed to draw subsistence allowance as admissible under Rule 53 (ii) (a) of the FRs and SRs, subject to production of non-employment certificate to the Principal Chief Conservator of Forest & HoFF under sub-rule (2) of FR 53.
