NOTIFICATION

Dated Dispur the 8th April, 2019

No.FEB.123/2019/24: Whereas report has been received from the Deputy Commissioner, Karbi-Anglong, Diphu vide letter No.KGC.188/2019/T.O/26 dated 02/04/2019 and stated that complaint was lodged against Sri Amarendra Sarma, Treasury Officer, Diphu Treasury and his staff for doing anomalies in clearing the bills, submitted in the Treasury.


Whereas an enquiry was conducted by the Deputy Commissioner, Karbi-Anglong, Diphu through Additional Deputy Commissioner, Karbi-Anglong, Diphu and Assistant Commissioner, Diphu on the complaint received against Sri Amarendra Sarma and his staff.

Whereas from the enquiry report it is revealed that Sri Amarendra Sarma, Treasury Officer, Diphu Treasury failed to monitor smooth clearance of the March ending Bills/Cheques and the Treasury staff has done partiality in disbursing the bills of the complainants by breaking the precedence of token issued.

In view of above, the Governor of Assam having been satisfied with the above facts and circumstances and pending drawal of Departmental Proceedings and in exercise of the power conferred under Rule 6 (1) of the Assam Services (Discipline and Appeal), Rules, 1964, Sri Amarendra Sarma is placed under suspension with immediate effect.

During the suspension period his headquarter has been fixed at Nagaon. The officer shall in no case leave the headquarter without prior approval of the Competent Authority.

Sri Amarendra Sarma AFS is allowed to draw subsistence allowances as admissible under provision of Rule 53(ii) (a) of the FRs and SRs subject to production of non-employment certificate under sub Rule (2) of F.R 53.
