Tabzul Hussain, AFS, Treasury Officer, New Guwahati Treasury shared his User Id and password with an unauthorized person for approving bills/cheques in the system which is grossly irregular.

Whereas from the report it is revealed that Md. Tabzul Hussain, AFS. Treasury Officer, New Guwahati Treasury did not monitor the status of payment regularly in the system which had attributed to non-payment of bills submitted by the Director, Social Welfare, Assam in respect of "Deen Dayal Divyangjan Pension Scheme" for the Financial Year 2018-2019.

In view of above, the Governor of Assam having satisfied with the above facts and circumstances and pending drawal of Departmental Proceedings and in exercise of the power conferred under Rule 6 (1) of the Assam Services (Discipline and Appeal), Rules, 1964, Md. Tabzul Hussain, AFS is placed under suspension with immediate effect.

During the suspension period his headquarter has been fixed at Guwahati. The officer shall in no case leave the headquarter without approval of the Competent Authority.

Md. Tabzul Hussain, AFS is allowed to draw subsistence allowances as admissible under provision of Rule 53(ii)(a) of the FRs and SRs subject to production of non-employment certificate under sub Rule (2) of F.R.53.
