TITLE : Views on amendment of the Assam Finance Service Rules, 2019

The proposed amendment of Rule 5(1) and rule 5(2) of the Assam Finance Service Rules 2019, as shown below is published hereby for information of all concerned. If there is any view or objection then the same may be submitted to the Secretary to the Government of Assam, Finance Establishment-B Department (email id : **syed.rahman@nic.in or rsyedisfaqur@yahoo.in** within 15 days.

Proposed amendment of rule 5(1) :

In the principal Rules, in rule 5 (1), the following shall be substituted, namely:-

"(1) (i) Recruitment to the cadres of Junior Grade II shall be made by direct recruitment against 70% of the cadre strength through Competitive Examination to be conducted by the Commission; and

(ii) Recruitment 30% of the cadre strength shall be made by promotion through Departmental (promotion) Examination to be conducted by the Commission from the members of the following cadre and the breakup of percentage shall be as follows:

- a. Dy. Accounts Officer/Accounts Officer under the Assam Accounts Service..... 10%
- b. Audit Officer under the Assam Subordinate Local Fund Audit Service10%
- c. Treasury Superintendent, Treasury Accountant and Senior Accounts Assistant under the District Treasury Service10%.

Provided that if sufficient number of candidates belonging to any of the cadres are not available, the vacancies reserved for one of these categories may be filled up by the other :

Provided further that a member of the service shall be eligible for Departmental (promotion) Examination who is a graduate from any recognized University and has rendered at least five (5) years of continuous service as Accounts Officer (including his service tenure as Deputy Accounts Officer) or a Deputy Accounts Officer or Audit Officer or a Treasury Superintendent, Treasury Accountant and Sr. Accounts Assistant in the Treasury establishment and who has not cross the age of 50 years on the first day of the year in which Departmental (promotion) Examination has been held.

Proposed amendment of rule 5(2) :

In the principal Rules, in rule 5 (2) the following shall be substituted, namely :-

"(2) The reservation of 70% and 30% quota for direct recruitment or promotion shall not be carried forward, if there is not sufficient candidate for promotion or direct recruitment at a time are not available."
