Subject :- SANCTION OF HOUSE RENT FOR PRIVATE HOUSE HIRED FOR GOVERNMENTAL PURPOSE.

In partial modification of Government instructions issued under circular letter No. FM. 20/67/Pt., dated. 18-12-67 relating to the sanction of house rent for private house hired for government purpose, the Governor of Assam is pleased to issue the following instructions and these will come into force with immediate effect.

The Executive Engineer, PWD (Building) will give "non availability certificate" at the time of initial fixation of the house rent and also at the time of fixation of the revised rent after expiry of five years. No non-availability certificate will be necessary from the Executive Engineer, PWD (Building) for the renewal of sanction and a certificate from the Head of the Department regarding non-availability of the Government accommodation would be sufficient for the sanctioning authority whether it is Head of the Department or the Administrative Department, to issue the sanction.
