**“RULE 24(B) Small Family Norms”-**

- (1) No government servant shall have more than two living children from a single or multiple partners on or after 1<sup>st</sup> January 2021:  
 Provided that one or more children born on or after the said date from a single subsequent delivery shall be deemed to be one entity while counting the number of children :  
 Provided further, that Government servants having more than two living children before 01-01-2021 shall not be deemed to commit misconduct so long as the number of children he/she has does not increase on or after 01-01-2021.
- (2) Every Government servant shall on his first appointment to any service or post and thereafter at such intervals, as may be specified by the Government, submit a **Declaration** giving the details of members of his family in the form appended to those rules.
- (3) Those persons who are already in Government service on the date of commencement of these rules shall also submit a **Declaration** giving the details of members of his family in the form as mentioned hereinabove within a period of thirty days from the date of commencement of these rules.
